We will discuss your Fire Risk Assessment report with you and plan a course of action, plus we will provide access to your online report in our secure portal.



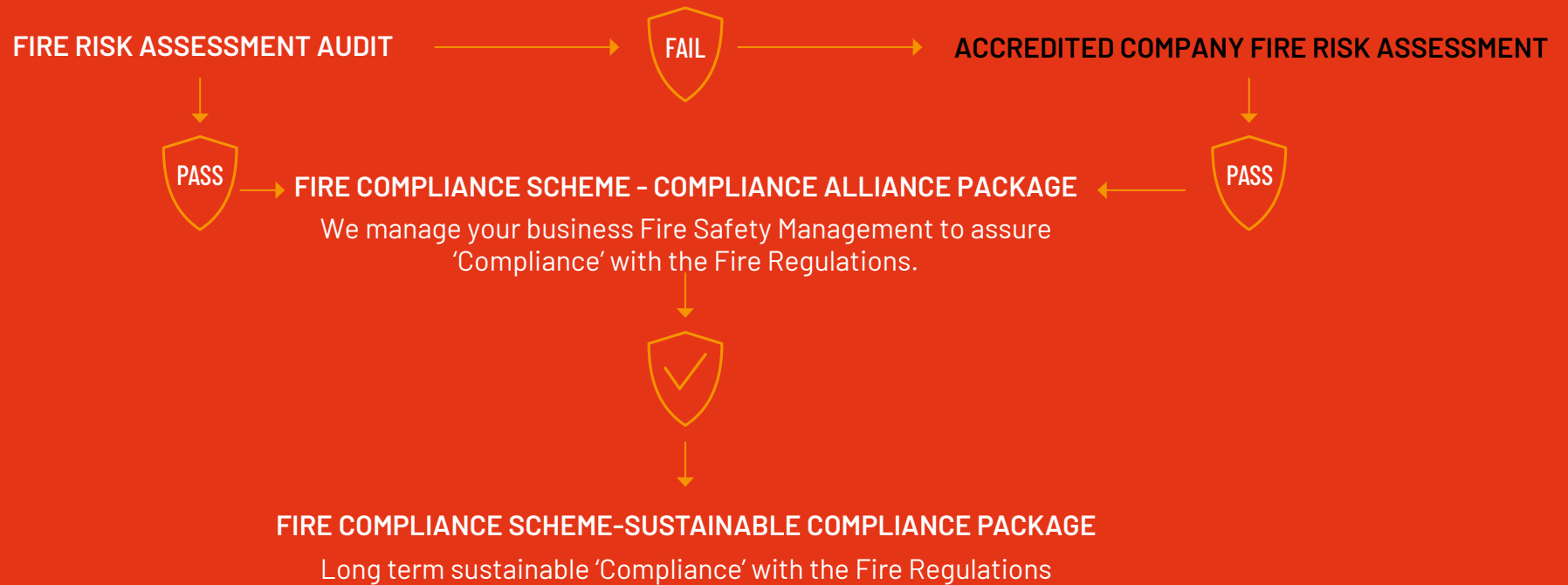
